The U.P. State Biodiversity Board is all set to celebrate a National Conference on "Forest Biodiversity" on **22nd May, 2011** at Lucknow. The exact venue of the Conference will be intimated shortly. The aim of the Conference is to provide an effective platform for all those who are concerned or dealing with conservation of biodiversity since it underpins the health and vitality of forests and also serves the basis for a wide range of ecosystem services necessary for people's livelihoods and well-beings.

Background:

Forests represent some of the most diverse ecosystems on Earth. With growing awareness of the role of forests in the global carbon cycle, interests in the World's forests have grown to unprecedented heights. But forests are more than just carbon. Forests provide employment and livelihood for a large proportion of the World's population, acting as a safety net in times of need. The World's total forest area is just over 4 billion hectares, which corresponds to an average of 0.6 ha per capita. India has 69.09 million ha of forests as per the FSI report of 2009. Forests are disappearing partly because they are undervalued, and our market economy fails to recognize ecosystem services provided by intact forests. To stop losing the earth planet's living treasure, we must understand and appreciate its importance for

human well being and development. There is an urgent need to restore the degraded forests in order to save forest biodiversity.

The CBD's expanded programme of work on forest biodiversity started in 2002, is a global action plan to safeguard biodiversity in forests. Celebration on this theme provides unique opportunity to raise public awareness on the importance of biodiversity to sustainable development.

The central theme of the conference is **"Forest Biodiversity"**. This conference presents and excellent opportunity for the forest community and stake holders to discuss advances on various aspects related to forestry.
